# HISTORY

## 1976

Barlow Justice began 35 years ago, as a partnership between O.B. Smith and John Barlow. Located on the second level of the Mutual Funds Building, the partnership became a well-regarded, locally owned business.

## 1980s

Erle Justice joined the team in 1981, and became a partner in 1982 when O.B. Smith retired. Smith would remain connected with the firm he helped establish, working as an associate out of a Wanaka-based office for a few years.

Peter Jackson joined in 1984, eventually becoming a partner.

## 1990s

The 1990s were a period of change for the company. The firm operated under five name variants, and moved house twice: first to 274 Stuart Street in 1994, and then to the present location, Level 8, 284 Cumberland Street, in 1998.

Ah-Lek Tay came on board in 1996, and John Barlow took leave due to ill health. Ah-Lek joined Erle as a director in 1997.

In 1999, Barlow Justice joined with five other owner-operated valuation firms in an association known as **Valuersnet NZ Ltd.**

## 2000s

Erle passed away in 2006 and Janice Taylor, who joined the firm in 2003, became a director the following year. Most of the current valuing staff began working at Barlow Justice during this period.

## 2010s

In 2010, Janice retired her shareholding and directorship in the firm. Anthony Taylor became a director. Gill Hormann, the longest serving support staff member, left the firm in November after almost 30 years.

## Today

2011 sees Barlow Justice Limited celebrating 35 years of helping the people of Dunedin and Otago with their property needs. Barlow Justice remains proudly Dunedin owned and operated.
